# PERSONAL GUARANTY AGREEMENT

On the default of Debtor in the payment of any of the installment of this instrument, **Schulhoff Tool Rental Inc.** representatives may enter the premises of Debtor or any premises where the property may be found, where it is found without hindrance or without making demand of any kind. **Schulhoff Tool Rental Inc.** may retain the money paid on this instrument, even though the property has been reclaimed by **Schulhoff Tool Rental Inc.** to the extent necessary to pay for the depreciation that occurred to the property prior to the time of retaking.

Debtor agrees to pay all expenses, including attorney's fees and legal expenses incurred by **Schulhoff Tool Rental Inc.** to collect any debt owed by the undersigned and/or to enforce the agreement. This agreement takes effect upon its acceptance by **Schulhoff Tool Rental Inc.**, and shall be interrupted under Ohio law, which state shall have exclusive jurisdiction and venue over any dispute regarding this agreement.
